This Cookie Policy describes technologies, the purpose of their use and your right to control their use. By continuing to browse our site, you agree to the use of cookies in accordance with this policy.

Definition of cookies

Cookies are small text files that are stored on your device (computer, tablet, smartphone) when you visit a website. They are widely used to make websites work more efficiently, as well as to provide information to the owners of the site about user interactions and help improving the overall performance and usability of the site. Cookies help improve your browsing experience by remembering your preferences, login details, and other settings. They may also be used for analytics and tracking purposes to understand how users interact with the website and give more personalized and convenient user experience. Types of Cookies We use

<u>Essential Cookies</u> are necessary for the basic operation of a website. Information collected includes page views, navigation paths, and
